ITEM TITLE	Designation of expenditures of Performance Based funding for a one- time employee stipend. In the Performance based account there is approximately \$84,000. Brenda received approval to disburse the majority of these funds as one-time stipends for certified and classified staff. A full-time employee will receive \$1,000 (actually \$1,200 - the-\$200 will cover benefits, and staff will pay taxes and deductions on the \$1,000). Part-time employees will receive a pro-rated stipend@ \$200 per day. The balance in this fund will be used to pay teacher assistant's next school year since the ESSR

ITEM TITLE	B. Designation of expenditures of Undesignated Tax Credit Funds for the 2023-2024 school year
DISCUSSION NOTES	District wants us to spend the \$83,755.23 in our undesignated funds before the \$400 million dollar bond is proposed to the taxpayers. Possible uses for money include: purchasing a shade cover over the basketball courts and over the ramp outside the red gate. Also, using funds to fix up the dilapidated portables - fix the ramps, deteriorated wood and skirting. Mrs. Encinas has requested the portables be fixed for the last two years. Another purchase could be Nest Security Cameras. There have been a handful of break-Ins at the school. The thought was to put three cameras around the school. One camera by the library, another by the portables, and by the playground. Another option was to purchase a new marquee in front of the school for approximately \$40,000.
